11	WHEREAS,	the Tohono O'odham Legislative Housing Committee has oversight over housing
12		matters and did interview the Board of Director candidates; and
13	WHEREAS,	there is an emphasis on the continuation of Ki:ki Association's overall goals and
14		objectives and the importance of a smoother transition; and
15	WHEREAS,	the Legislative Housing Committee recommends the appointment of Jonas Robles to
16		the TohonoO'odhamKi: Ki AssociationBoardofDirectorseffectiveuponapprovaland
17		ending February 10, 2005.
