

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Nominating Councilman Dennis Jose and Ki:Ki Association Director Loren Goldtooth
to serve on the IHBG Negotiated Rulemaking Committee)

RESOLUTION NO. 01-439

1 **WHEREAS, the Indian Housing Block Grant Program Allocation Formula ("IHBG") establishes a**
2 **method for allocating funds under the Native American Housing Assistance and Self-**
3 **Determination Act ("NAHASDA") (25 U.S.C. § 4101 et seq.); and**

4 **WHEREAS, the United States Department of Housing and Urban Development ("HUD") is**
5 **requesting that Indian tribes nominate qualified individuals for appointment to a**
6 **negotiated rulemaking committee which will review and negotiate modifications or**
7 **revisions to the IHBG; and**

8 **WHEREAS, the Nation's membership on the negotiated rulemaking committee would act as a**
9 **means of recognizing the Nation's sovereign status and would serve to strengthen its**
10 **government-to-government relationship with the United States; and**

11 **WHEREAS, written nominations to the negotiated rulemaking committee must include specific**
12 **criteria set out in 24 C.F.R §1000 (2001); and**

13 **WHEREAS, the Legislative Council finds that Councilman Jose and Tohono O'odham Ki:Ki**
14 **Association Director Loren Goldtooth meet these criteria as follows:**

- 15 **1. Councilman Jose is an elected official of the Tohono O'odham Legislative Council**
16 **and has demonstrated housing experience as the Chairman of the Legislative**
17 **Housing Committee and a member of the Ki:Ki Association Board; and**
- 18 **2. Loren Goldtooth has demonstrated housing experience as the Ki:Ki (Housing)**
19 **Association Director and, if appointed to the negotiated rulemaking committee,**
20 **he is authorized to act on behalf of the Tohono O'odham Nation during the**
21 **negotiated rulemaking sessions; and**
- 22 **3. Councilman Jose and Loren Goldtooth have both made a commitment and are**
23 **willing to actively participate in good faith in the development of the rule under**
24 **consideration; and**
- 25 **4. The nominees represent an Indian tribe with more than 24,000 members and**
26 **tribal government with jurisdiction over the second largest reservation within**
27 **the United States; their selection will help to ensure the negotiated rulemaking**


- 1 committee contains representatives from a large Indian tribal government; and
2 5. The nominees represent an Indian tribe with a 2.8 million acre land base in
3 Southern Arizona; their selection will help ensure the geographic diversity of the
4 committee membership; and
5 6. Councilman Jose and Loren Goldtooth have shown the ability to analyze and
6 extrapolate complex data.

7 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council nominates**
8 **Councilman Dennis Jose and Ki:Ki Association Director Loren Goldtooth (as**
9 **Councilman Jose's alternate) to the IHBG negotiated rulemaking committee.**

10 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**
11 **Councilman Dennis Jose and Ki:Ki Association Director Loren Goldtooth to act on**
12 **behalf of the Tohono O'odham Nation during the IHBG negotiated rulemaking**
13 **sessions.**


14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
15 **of AUGUST, 2001 at a meeting at which a quorum was present with a vote of 2,169.45 FOR; 248.05**
16 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
17 **Section 1 (b) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
18 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
20 **18, 1934 (48 Stat. 984).**




