1                   and that their application is approved, as herein above indicated.

2 **BE IT FURTHER RESOLVED** that the Chairman and other appropriate officers of the Tohono

3 O'odham Nation reduce this final determination in writing regarding each of the

4 foregoing applications for enrollment in accordance with Section 1(a) of Article

5 XIII of the Enrollment Ordinance; give notice of this Council's determination in

6 accordance with Section 2 of Article XIII of the Enrollment Ordinance; and place

7 the names of each applicant upon the membership roll of the Tohono O'odham

8 Nation in accordance with Sections 2 and 3 of Article X of the Enrollment

9 Ordinance.

10 The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 10<sup>TH</sup> Day

11 of SEPTEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,325.15 FOR;

12 92.35 AGAINST; -0- NOT VOTING; and[-0-] ABSENT, pursuant to the powers vested in the Council

13 by Section 1 of Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'Odham

14 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting

15 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16

16 of the Act of June 18, 1934 (48 Stat. 984).
