RESOLUTION NO. 01-455

1 WHEREAS, the Tohono O'odham Nation Department of Human Services is presently operating the  
2 Division of Child Welfare Services-Children's Home Program component under the  
3 P.L. 93-638 Master BIA Contract; and

4 WHEREAS, budget modification No. 2 for the Children's Home Program is submitted to increase  
5 line items and to add line item 727 Building Materials; and


6 WHEREAS, there is no change in the grand total.

7 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:

- 8 1. That it hereby approves and authorizes expenditures in accordance with the  
9 attached budget modification No. 2 submitted by the Department of Human  
10 Services.
- 11 2. That the Tohono O'odham Nation's Official to wit, the Chairman, Vice Chairman  
12 and any designated official are hereby authorized to negotiate and execute the  
13 contract.

14 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>th</sup> day  
15 of SEPTEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-  
16 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by  
17 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
18 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
19 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
20 18, 1934 (48 Stat. 984).
