

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Amendment No. 1 to the Attorney Contract with Buescher &**  
**Franke, L.L.C.)**

**RESOLUTION NO. 01-457**

1 **WHEREAS, by Resolution No. 2000-495, the Tohono O'odham Legislative Council approved an**  
2 **Attorney Contract with Buescher & Franke, L.L.C. to provide legal representation to the**  
3 **Nation in connection with a case pending in Missouri under the Indian Child Welfare**  
4 **Act; and**

5 **WHEREAS, the Attorney Contract is in the amount of \$5,000 for fiscal year 2001; and**

6 **WHEREAS, the additional sum of \$5,000 is required for legal fees and expenses to assure**  
7 **uninterrupted legal representation for fiscal year 2001; and**

8 **WHEREAS, sufficient funds are available in the budget of the Office of Attorney General to**  
9 **supplement the Attorney contract by such amount; and**


10 **WHEREAS, the Domestic Affairs Committee recommends approval of Amendment No. 1 to the**  
11 **Attorney Contract to increase the Contract amount by \$5,000.**

12 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 13           **1. The Tohono O'odham Legislative Council hereby approves Amendment No. 1 to**  
14 **the Attorney Contract with Buescher & Franke, L.L.C. in the form attached hereto,**  
15 **which increases the Contract amount by \$5,000 payable from the fiscal year 2001**  
16 **operating budget of the Office of Attorney General.**
- 17           **2. The Chairman of the Nation is authorized and directed to execute Amendment No.**  
18 **1 to such Contract.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> day**  
20 **of SEPTEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
25 **Stat. 984).**


