6	WHEREAS, the additional sum of \$5,000 is required for legal fees and expenses to assure
7	uninterrupted legal representation for fiscal year 2001; and
8	WHEREAS, sufficient funds are available in the budget of the Office of Attorney General to
9	supplement the Attorney contract by such amount; and
10	WHEREAS, the Domestic Affairs Committee recommends approval of Amendment No. 1 to the
11	Attorney Contract to increase the Contract amount by \$5,000.
12	NOW, THEREFORE, BE IT RESOLVED THAT:
13	1. The Tohono O'odham Legislative Council hereby approves Amendment No. 1 to
14	the Attorney Contract with Buescher & Franke, L.L.C. in the form attached hereto,
15	which increases the Contract amount by \$5,000 payable from the fiscal year 2001
16	operating budget of the Office of Attorney General.
17	2. The Chairman of the Nation is authorized and directed to execute Amendment No.
18	1 to such Contract.
