(In Support of the Johnson-O'Malley Program FY 2001, Budget Modification
#3 Acct. #10-1210)

RESOLUTION NO. 01-461

1 WHEREAS, the Tohono O'odham Nation has successfully operated the Johnson-O'Malley Program
2 for numerous years under the Master Contract; and


3 WHEREAS, the Johnson-O'Malley Program has a final allocation reduction for FY 2001, due to the
4 BIA reduction resulting in the amount of \$370.70.

5 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
6 Johnson O'Malley Program budget modification #3 reflecting the 22% across the
7 board reduction, in the amount of \$370.70.

8 BE IT FINALLY RESOLVED that the Johnson-O'Malley Program budget of \$371,105.89 has decreased
9 to \$370,735.19 for F.Y. 2001.

10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH day
11 of SEPTEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-
12 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
13 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
14 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
15 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
16 18, 1934 (48 Stat. 984).
