(Approving Amendment No. 1 to Attorney Contract with Robert R. Yoder)**

RESOLUTION NO. 01-464

1 **WHEREAS, by Resolution No. 2000-493, the Tohono O'odham Legislative Council approved an**
2 **Attorney Contract with the law firm of Robert R. Yoder P.C. for legal services related**
3 **to the Tohono O'odham Nation 401(K) Plan; and**

4 **WHEREAS, the additional sum of \$3,000.00 is required for legal fees and expenses to assure**
5 **uninterrupted legal representation for fiscal year2001; and**

6 **WHEREAS, sufficient funds have been budgeted in the employee benefits expense item to**
7 **supplement the Attorney Contract in such amount; and**


8 **WHEREAS, the Commerce, Domestic Affairs and Budget & Finance Committees recommend**
9 **approval of Amendment No. 1 to the Attorney Contract to increase the Contract**
10 **amount by \$3,000.00.**

11 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 12 **1. The Tohono O'odham Legislative Council approves Amendment No. 1 to the**
13 **Attorney Contract with the law firm of Robert R. Yoder P.C., in the form attached**
14 **hereto, which increases the Contract amount by \$3,000.00 for fiscal year 2001,**
15 **payable from the fiscal year 2001 budget account number 01-1006-605.**
- 16 **2. The Chairman of the Nation is authorized and directed to execute Amendment No.**
17 **1 to such Contract.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day**
19 **of SEPTEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,302.15 FOR; -0-**
20 **AGAINST; 115.35 NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
22 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**
