RESOLUTION NO. 01-469

1 WHEREAS, the Hickiwan District, at a special meeting on September 10, 2001 met to discuss the
2 Hickiwan District FY 2002 Budget; and

3 WHEREAS, the Hickiwan District sees a need for the continued use of the FY 2001 funds to allow
4 the District to set forth its FY 2002 Budget for approval; and

5 WHEREAS, the Hickiwan District has sufficient funds in the First Union Securities account to
6 cover costs; and


7 WHEREAS, the FY 2002 Budget will be presented at a following October or November session of the
8 Legislative Council.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and
10 supports the need for the continued use of the FY 2001 Funds for the Hickiwan District
11 and the FY 2002 Budget will be presented at a following October or November session.

12 BE IT FURTHER RESOLVED by the Legislative Council that Hickiwan District does have sufficient
13 funds in the First Union Securities to cover these costs.

14 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day
15 of SEPTEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-
16 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
17 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by
18 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
19 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
20 18, 1934 (48 Stat. 984).






