# **RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL** (Supporting Gu Achi District FY-2002 Budget)

RESOLUTION NO. 01-473

1	WHEREAS,the Gu Achi District Council on August 17, 2001 approved the FY-2002 budget in the
2	amount of \$812, 745.00, \$757, 644.83 from the gaming revenues and \$55, 100.17 from the
3	Gu Achi District surplus monies from its current FY-2001 budget; and
4	WHEREAS, gaming revenue monies for Gu Achi District FY-2002 will be deposited in account
5	#38297624 with First Union Securities; and
6	WHEREAS, the GuAchi District Council understands that any budget modification throughout FY-
7	2002 is at their discretion.
8	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council has reviewed
9	and approves the Gu Achi District FY-2002 budget in the amount of \$812,745.00.
10	BE IT FURTHER RESOLVED that the Legislative Council authorizes use of carryover dollars in the
11	amount of \$55,100.17 from the FY-2001 Gu Achi District budget into its FY-2002 budget.
12	BE IT FINALLY RESOLVED that any amendments to the FY-2002 budget, which includes new monies
13	or would involve a separate line item not within the FY-2002 district budget shall be
14	approved by the Tohono O'odham Legislative Council.
15	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the <u><math>13^{TH}</math></u> . Day
16	of SEPTEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-
17	AGAINST; <u>-0-</u> NOT VOTING; and <u>-0-</u> ABSENT, pursuant to the powers vested in the Council by Section
18	1 <u>(d)(2) and (3)</u> of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
19	Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
20	Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
21	18, 1934 (48 Stat. 984).
