

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Rescinding Resolution No. 223-86, "Approving delegation of authority to Chairman
and Vice Chairman of Legislative Council")

RESOLUTION NO. 01-476

1 **WHEREAS, Article V, Section 4 of the Constitution of the Tohono O'odham ("Constitution") grants**
2 **the Tohono O'odham Council power to elect and delegate authority to the Council**
3 **Chairperson and Vice Chairperson; and**

4 **WHEREAS, the Legislative Council is further vested with the power "[t]o provide for . . . and**
5 **prescribe the duties and powers of . . . officers . . . provided that no such . . . officer . . .**
6 **shall exercise powers of the Tohono O'odham Council unless they are expressly**
7 **delegated by the Tohono O'odham Council (Constitution, Article VI, Section 1(b)); and**

8 **WHEREAS, the Council has prescribed the duties and powers of the Legislative officers by**
9 **adopting the Legislative Rules and by passing Resolution No. 223-86, "Approving**
10 **delegation of authority to Chairman and Vice Chairman of Legislative Council"; and**


11 **WHEREAS, the Rules Committee has reviewed Resolution No. 223-86 and recommends that the**
12 **delegations of authority be revised and updated to reflect the Legislative officers'**
13 **existing roles in administering the Legislative Branch, supervising Branch employees,**
14 **and performing other functions not specifically addressed in Resolution No. 223-86;**
15 **and**

16 **WHEREAS, because the updated delegations will replace Resolution No. 223-86, it is necessary to**
17 **rescind Resolution No. 223-86.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**
19 **it hereby rescinds Resolution No. 223-86, "Approving delegation of authority to**
20 **Chairman and Vice Chairman of Legislative Council."**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
22 **of SEPTEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
24 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat. 984).**


