4	WHEREAS, the Legislative Council is further vested with the power "[t]o provide for \ldots and
5	prescribe the duties and powers of officers provided that no such officer
6	shall exercise powers of the Tohono O'odham Council unless they are expressly
7	delegated by the Tohono O'odham Council (Constitution, Article VI, Section 1(b)); and
8	WHEREAS, the Council has prescribed the duties and powers of the Legislative officers by
9	adopting the Legislative Rules and by passing Resolution No. 223-86, "Approving
10	delegation of anthority to Chairman and Vice Chairman of Legislative Council"; and
11	WHEREAS,the Rules Committee has reviewed Resolution No. 223-86 and recommends that the
12	delegations of authority be revised and updated to reflect the Legislative officers'
13	existing roles in administering the Legislative Branch, supervising Branch employees,
14	and performing other functions not specifically addressed in Resolution No. 223-86;

16	WHEREAS, because the updated delegations will replace Resolution No. 223-86, it is necessary to
17	rescind Resolution No. 223-86.
18	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that
19	it hereby rescinds Resolution No. 223-86, "Approving delegation of authority to
20	Chairman and Vice Chairman of Legislative Council."
