LEGISLATIVE ORDER NO. 01-477

1	WHEREAS, Article V, Section 4 of the Constitution of the Tohono O'odham ("Constitution") grants							
2	the Tohono O'odham Council power to elect and delegate authority to the Council							
3	Chairperson and Vice Chairperson; and							
4	WHEREAS, the Legislative Council is further vested with the power "[t]o provide forand							
5	prescribe the duties and powers ofofficersprovided that no suchofficershall							
6	exercise powers of the Tohono O'odham Council unless they are expressly delegated							
7	by the Tohono O'odham Council (Constitution, Article, VI, Section 1(b)); and							
8	WHEREAS, the Council has prescribed the duties and powers of the Legislative officers by							
9	adopting the Legislative Rules and by passing Resolution No. 223-86, "Approving							
10	delegation of authority to Chairman and Vice Chairman of Legislative Council"; and							
11	WHEREAS,the Rules Committee has reviewed Resolution No. 223-86 and recommends that the							
12	delegations of authority be revised and updated to reflect the Legislative officers							
13	existing roles in administering the Legislative Branch, supervising Branch employees							
14	and performing other functions not specifically addressed in Resolution No. 223-86							
15	and							
16	WHEREAS, the Legislative Council has reviewed the Rules Committee's recommendations and							
17	hereby approves the delegations of authority incorporated into this Order.							
18	NOW, THEREFORE, BE IT ORDERED by the Legislative Council that it does hereby delegate the							
19	following authorities to the Chairperson in addition to any authority otherwise							
20	delegated to the Chairperson:							
21	The Legislative Chairperson shall have authority to:							
22	1. Preside over all Council sessions.							
23	2. Rule on questions of procedure during Council sessions, subject to appeal of the							
24	Council.							
25	3. Maintain order and decorum at all Legislative proceedings and events.							
26	4. Follow up on implementation of legislation.							
27	5. Sign all legislation and Legislative Branch documents.							
28	6. Act as ex-officio, non-voting member of all Legislative Council Committees.							
29	7. Act as official liaison to the Nation's Executive and Judicial Branches.

2	8. Prepare and present an annual Legislative Branch budget to the Legislative							
3	Council for its review and approval.							
4	9. Allocate funds, staff, and other resources for the effective operation of the							
5	Legislative Branch.							
6	10. Approve Legislative Branch expenditures.							
7	11. Exercise general administrative control over Legislative Branch offices,							
8	buildings, chambers and property.							
9	12. Supervise and delegate the supervision of Legislative Branch employees.							
10	13. Determine the employment and compensation of Legislative Branch employees.							
11	14. With the consent of a majority of the Legislative Council, authorize litigation on							
12	the Council's behalf.							
13	BE IT FINALLY ORDERED by the Legislative Council that it does hereby delegate the following							
14	authorities to the Vice Chairperson in addition to any authority otherwise delegated							
15	by the Council or applicable laws:							
16	<u>The Legislative Vice Chairperson shall have authority to</u> :							
17	1. In the absence of the Chairperson, exercise all the duties and powers of the							
18	Chairperson.							
19	2. Perform those duties assigned by the Chairperson.							
20	3. At the Chairperson's request, assist the Chairperson in the performance of any							
21	duties.							
22	4 . Act as ex-officio, non-voting member of all Legislative Council Committees.
