RESOLUTION NO. 01-480

1 **WHEREAS, the Tohono O'odham Nation is presently operating the Tohono O'odham Psychological**
2 **Services through a P.L. 93-638 contract and I.H.S. carryover monies; and**

3 **WHEREAS, the Psychological Services Division has received notification from Tohono O'odham**
4 **Nation Grants and Contracts of I.H.S. unspent monies in the amount of \$86,847.59 for**
5 **a total of \$699,955.00; and**


6 **WHEREAS, the Psychological Services Division has produced a budget modification using the**
7 **unspent monies to cover personnel (including one position transferred from the FY**
8 **2001 TODHS SMI Program Revenue Funds Budget) and operational expenses for FY**
9 **2001.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:**

- 11 **1. That it hereby approves the attached FY 2001 Tohono O'odham Psychological**
12 **Services IHS Modification #1 in the amount of \$699,955.00**
- 13 **2. That the Tohono O'odham Nation's Official to wit: the Chairman, Vice Chairman**
14 **and any designated Officer are hereby authorized to negotiate and execute the**
15 **proposal.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
17 **of SEPTEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
18 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
19 **Section 1 (Q) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
20 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
22 **18, 1934 (48 Stat. 984).**




