

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Tohono O'odham Department of Human Services - Division of Psychological Services - FY 2001 TODHS SMI Program Revenue Funds Budget Modification #1)

RESOLUTION NO. 01-481

1 **WHEREAS, the Tohono O'odham Nation is currently operating the Tohono O'odham Psychological**
2 **Services Treatment Program for the Seriously Mentally Ill Tas Tonlik Ki Day Program**
3 **through revenue funds, I.H.S. contract and I.H.S. carryover monies; and**

4 **WHEREAS, the FY 2001 Budget is to continue to utilize revenue funds, I.H.S. contract and I.H.S.**
5 **carryover monies to cover the SMI Day Program for the fiscal year (October 01, 2000**
6 **to September 30, 2001); and**

7 **WHEREAS, the program had prepared the FY 2001 SMI Revenue Funds Budget to use projected**
8 **funds generated through third party billing to cover the personnel expenses for the**
9 **fiscal year (October 01, 2000 to September 30, 2001) in the amount of \$154,922.86; and**

10 **WHEREAS, the program has prepared the FY 2001 SMI Revenue Funds Budget Modification #1 to**
11 **decrease the budget amount from \$154,922.86 to \$116,746.84 due to the transfer of one**
12 **position to the TOPS I.H.S. contract #10-1440 which has received an allocation**
13 **increase.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:**

- 15 **1. That it hereby approves the FY 2001 TODHS SMI Revenues Fund Budget**
16 **Modification #1 at \$116,746.84 to cover personnel expenses effective October 01,**
17 **2000 to September 30, 2001.**
- 18 **2. That the Department of Human Services requests transfer of one position from**
19 **the TODHS Special Revenues Fund Budget to the I.H.S. TOPS Contract Budget.**
- 20 **3. That the Tohono O'odham Nation's Officials, to wit: the Chairman, Vice Chairman**
21 **and any designated Officer are hereby authorized to negotiate and execute the**
22 **proposal.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
24 **of SEPTEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [2] ABSENT, pursuant to the powers vested in the Council by Section**
26 **1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
27 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
29 **Stat. 984).**


