
1 WHEREAS, the Tohono O'odham Nation through Legislative Council Resolution No. 97-265,
2 approved a five (5) year project to develop and implement a Home Health Agency; and
3 WHEREAS, the Tohono O'odham Nation is presently developing a Home Health Agency under
4 I.H.S. Grant #ISH002103-02 with the Indian Health Services; and
5 WHEREAS, a budget for a year five (5) in the amount of \$176,868.00 is submitted for review and
6 approval to continue the implementation of a Home Health Agency.

7 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:

- 8 1. It hereby approves the submission of the Elder Health Care budget for year five.
- 9 2. The Tohono O'odham Nation Officials, to wit: the Chairman is hereby authorized
10 to negotiate and execute contracts associated with this grant and to expend funds
11 when received.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day
13 of SEPTEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-
14 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
15 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
16 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
18 18, 1934 (48 Stat. 984).
