8	the San Xavier District to use supplemental gaming revenues in the amount of five
9	hundred thousand (\$500,000) for new home construction and renovations to existing
10	homes.
11	BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby sanctions the
12	attached budget for the above stated purposes and that the funds be immediately wire
13	transferred to the District upon approval of this resolution.
14	BE IT FINALLY RESOLVED that Resolution No. 01-484 is hereby amended to include that the
15	supplemental budget will be effective until December 2002.
