

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Baboquivari District FY 2002 Budget)

RESOLUTION NO. 01-486

1 **WHEREAS, on September 12, 2001 the Baboquivari District Council did meet and approved the FY**
2 **2002 Baboquivari District Budget; and**

3 **WHEREAS, the District Council did approve gaming revenues in the amount of \$903,969.12 to be**
4 **divided among the six (6) communities and the district administration, with 30% to**
5 **administration and 70% to be divided among the communities; and**


6 **WHEREAS, the following distribution of gaming revenues is allocated to the communities and**
7 **administration of the Baboquivari District totaling the amount of \$903,969.12:**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
17 **the Baboquivari District FY 2002 Budget in the amount of \$903,969.12 to be distributed**
18 **with 30% to Baboquivari District Administration in the amount of \$271,190.73 and 70%**
19 **to be divided among the six (6) communities of Baboquivari District in the amount of**
20 **\$105,463.06 each totaling \$632,778.39.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
22 **of SEPTEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
24 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat. 984).**


