
1 WHEREAS, the San Lucy District Council by Resolution No. SL-09-118-01, approved to continue
2 district operations pending completion of its FY 2002 budget and request district
3 representatives to introduce this matter before the Tohono O'odham Legislative
4 Council for consideration; and

5 WHEREAS, the Tohono O'odham Legislative Council has reviewed the request from the San Lucy
6 District and determined that it would be in the best interest of the district to continue
7 district operations pending completion of the FY 2002 budget.

8 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
9 approves continued operation of the San Lucy District at the FY 2001 budget levels.

11 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day
12 of SEPTEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-
13 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
14 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by
15 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
16 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
17 18, 1934 (48 Stat. 984).
