

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of No-Cost Extension for the CAA Section 103 - Air Quality Assessment
Project, Assistance Amendment X-98953901-1)

RESOLUTION NO. 01-488

1 **WHEREAS, in Resolution No. 2000-100, the Legislative Council accepted the \$144,363.00 award for**
2 **the CAA Section 103 - Air Quality Assessment Project grant; and**

3 **WHEREAS, the project period for that grant ran from February 14, 2000 to September 30, 2001;**
4 **and**

5 **WHEREAS, the Air Quality Specialist position was not filled until March 19, 2001, necessitating an**
6 **extension of the project period end date to allow the program to complete the work**
7 **plan tasks; and**

8 **WHEREAS, the Tohono O'odham Nation Environmental Protection Agency (TONEPA) has**
9 **requested and received from the United States Environmental Protection Agency**
10 **(USEPA) a no-cost extension for this grant until December 31, 2002 in Assistance**
11 **Amendment # X-98953901-01.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
13 **of the No-Cost Extension for the CAA Section 103 - Air Quality Assessment Project,**
14 **Assistance Amendment X-98953901-1.**

15 **BE IT FURTHER RESOLVED by the Tohono O'odham Nation Legislative Council that the Tohono**
16 **O'odham Nation's Official, to wit: the Chairman, Vice Chairman and any designated**
17 **official are hereby authorized to negotiate and execute the grant, provided however,**
18 **that any amendments affecting the funding for funding levels of the grant shall be**
19 **submitted for further prior approval.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Environmental Protection Agency**
21 **(TONEPA) is authorized to expend funds for the revised project period of April 01, 2000**
22 **to December 31, 2002.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
24 **of SEPTEMBER, 2001 at a meeting at which a quorum was present with a vote of 1,776.55 FOR;**
25 **640.95 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council**
26 **by Section 1 (g) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
27 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**


