

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval and Acceptance of the Application for the Superfund CORE Grant and  
Approval for Expenditure of Attached Budget)**

**RESOLUTION NO. 01-490**

1 **WHEREAS, the Tohono O'odham Nation is devoted to the goals of protecting the environment and**  
2 **safe guarding the health and well being of the Nation's members; and**

3 **WHEREAS, Article XVIII of the Constitution of the Tohono O'odham Nation sets out the Council's**  
4 **continuing responsibility to assure for all members safe and healthful surroundings;**  
5 **and**

6 **WHEREAS, the United States Environmental Protection Agency (USEPA), Region IX, Superfund**  
7 **Division announced there is available cooperative agreement funds in the amount of**  
8 **\$75,000 to continue the existing Superfund Consolidated Block program; and**

9 **WHEREAS, the Tohono O'odham Nation prepared a grant application to EPA, Region IX Superfund**  
10 **Division for Cooperative Agreement Funds.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
12 **the Tohono O'odham Nation Superfund Consolidated Block Grant application to EPA,**  
13 **Region IX Superfund Division.**

14 **BE IT FURTHER RESOLVED that the Council accepts the grant funding that the EPA has reserved**  
15 **for the Tohono O'odham Nation in the amount of \$75,000 and \$5,000 in in-kind**  
16 **services.**

17 **BE IT FURTHER RESOLVED by the Tohono O'odham Nation Legislative Council that the Tohono**  
18 **O'odham Nation's Officials, to wit: the Chairman, Vice Chairman and any designated**  
19 **officials are hereby authorized to negotiate and execute the grant, provided however,**  
20 **that any amendments affecting the funding or funding levels of the grant shall be**  
21 **submitted for further prior approval.**

22 **BE IT FURTHER RESOLVED that the Superfund Consolidated Block program is authorized to**  
23 **expend funds from this grant through the attached budget beginning on October 01,**  
24 **2001.**

25 **BE IT FURTHER RESOLVED that this Resolution supercedes Resolution No. 01-454 only as it**  
26 **pertains to the Superfund CORE Program grant.**

27 **BE IT FINALLY RESOLVED that FY 2001 base salary rates will be utilized.**


