


RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization for the Continuation of the Gu-Vo District's FY'00/01 Budget
Pending FY'01/02 Budget Approval)

RESOLUTION NO. 01-491

1 WHEREAS, the Gu-Vo District Governing Council held a Special Meeting on September 13, 2001 to
2 discuss the request for continuation of the District Administration budget; and
3 WHEREAS, the Gu-Vo District has determined that it is in the best interest of the District
4 Administration to request for a continuation of their FY'00/01 Budget from October
5 01, 2001 to November 30, 2001; and
6 WHEREAS, the Gu-Vo District does have sufficient funds to continue its District operations
7 pending approval of its FY'01/02 Budget.
8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
9 the request for continuation of the Gu-Vo District FY'00/01 Budget.
10 BE IT FURTHER RESOLVED that the continuing resolution be from October 01, 2001 to
11 November 30, 2001.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day
13 of SEPTEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-
14 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
15 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
16 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
18 18, 1934 (48 Stat. 984).




