
1 WHEREAS, the following named person(s) have formally relinquished their membership in the

4 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby
5 recognize that the above-named person(s) have relinquished their membership in
6 this Nation, and does hereby order that their name(s) be deleted from the
7 membership roll.


8 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day
9 of OCTOBER, 2001 at a meeting at which a quorum was present with a vote of 2,302.15 FOR; -0-
10 AGAINST; 115.35 NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by
11 Article II, Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham Nation,
12 adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy
13 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
14 of June 18, 1934 (48 Stat. 984).
