| 10       | WHEREAS, the Agriculture Committee of the Tohono O'odham Legislative Council has oversight                       |
| 11       | responsibility for the Tohono O'odham Nation's agricultural interests; and                                       |
| 12       | WHEREAS, the Agriculture Committee has discussed and recommends to the Tohono O'odham                            |
| 13       | Legislative Council the appointment of Patricia Cruz as the Tohono O'odham Nation's                              |
| 14       | voting delegate to the Intertribal Agriculture Council.  |
