## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Funding the TOUA Subsidy Implementation Plan in the Amount of \$1 Million)

RESOLUTION NO. 01-527

1	WHEREAS, on June 28, 1997, the voters of the Tohono O'odham Nation approved Initiative No. IN-
2	01-97 (the "Initiative") which sets aside \$1 million to establish a welfare fund to
3	provide qualified elderly and low-income members of the Nation with assistance
4	payments covering the cost of utility services provided by the Tohono O'odham Utility
5	Authority; and
6	WHEREAS, in order to implement the Initiative, the Tohono O'odham Legislative Council did
7	adopt the Initiative Funding and Implementation Plan of October 14, 1997 by
8	Resolution No. 97-451; and
9	WHEREAS, the Tohono O'odham Legislative Council did approve the TOUA Subsidy
10	Implementation Plan of November 3, 1998 by Resolution No. 98-473; and
11	WHEREAS, TOUA has applied \$2,000,000 to eligible members through September 2001 and the
12	funding has been exhausted in September 2001.
13	NOW, THEREFORE, BE IT RESOLVED that the Legislative Council hereby approves the transfer of
14	\$1 million from the Savings to TOUA for FY 2002.
15	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the $11^{ m TH}$ . Day
16	of OCTOBER, 2001 at a meeting at which a quorum was present with a vote of 1,248.25 FOR; 902.4
17	AGAINST; 266.85 NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by
18 19	Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
20	Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
21	18, 1934 (48 Stat. 984).
