**RESOLUTION NO. 01-528**

1 **WHEREAS, the Schuk Toak District Council convened at their regular Council meeting on October**  
2 **10, 2001; and**

3 **WHEREAS, the Schuk Toak District Council did review their proposed budget for FY - 2002 in the**  
4 **total amount of \$588,638.00; and**

5 **WHEREAS, the Schuk Toak District will be utilizing the Gaming Revenues that was allocated to the**  
6 **district in the total amount of \$588,638.00; and**

7 **WHEREAS, the Schuk Toak District FY - 2002 budget will commence on October 01, 2001 and end**  
8 **on September 30, 2002.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does approve**  
10 **and support the Schuk Toak District FY - 2002 Budget in the total amount of**  
11 **\$588,638.00.**

12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day**  
13 **of OCTOBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**  
14 **AGAINST; -0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by**  
15 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
16 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
17 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
18 **18, 1934 (48 Stat. 984).**
