

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with California
Indian Legal Services)

RESOLUTION NO. 01-530

1 **WHEREAS, pursuant to Legislative Council Resolutions 99-590 and 2000-496, the Nation entered**
2 **into an Attorney Contract with California Indian Legal Services (the "Attorneys") for**
3 **the purpose of providing legal representation to protect the Nation's interests under**
4 **the Indian Child Welfare Act in connection with legal proceedings in the State of**
5 **California; and**

6 **WHEREAS, the Attorney Contract expired on September 30, 2001; and**

7 **WHEREAS, continued representation is necessary to protect the Nation's interests in these**
8 **proceedings; and**

9 **WHEREAS, the Operating Budget for the Office of Attorney General for the first quarter of Fiscal**
10 **Year 2002, as approved by the Legislative Council in Resolution No. 01-454, has**
11 **sufficient funds for an attorney contract in the amount of \$20,000.00 for**
12 **representation in these proceedings; and**

13 **WHEREAS, the Attorney General has proposed an attorney contract with California Indian Legal**
14 **Services, in the amount of \$20,000.00, a copy of which is attached hereto; and**

15 **WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of**
16 **an Attorney Contract with the Attorneys on such terms.**

17 **NOW THEREFORE, BE IT RESOLVED THAT:**

- 18 **1. The Tohono O'odham Legislative Council hereby approves an Attorney Contract**
19 **with California Indian Legal Services in the amount of \$20,000 for the period**
20 **ending December 31, 2001 and in the form attached hereto.**
- 21 **2. Funding for the Attorney Contract shall be provided under the authority of**
22 **Resolution No. 01-454 in the operating budget for the Office of Attorney General.**
- 23 **3. The Chairman of the Nation is authorized and directed to execute the Attorney**
24 **Contract.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
27 **of OCTOBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
29 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
