

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with the Law Firm of
Slosser, Hudgins, Struse & Freund)

RESOLUTION NO. 01-532

1 **WHEREAS, an Initiative, No. IN-01-97 (the "Initiative"), was approved by the voters of the Tohono**
2 **O'odham Nation on June 28, 1997; and**

3 **WHEREAS, pursuant to Legislative Council Resolution Nos. 99-595 and 2000-500, the Nation**
4 **entered into an Attorney Contract with the law firm of Slosser, Hudgins, Struse &**
5 **Freund (the "Attorneys") to assist the Office of Attorney General in assessing the tax**
6 **implications for the Nation and its members associated with the implementation of**
7 **the Initiative; and**

8 **WHEREAS, the Attorney Contract expired on September 30, 2001; and**

9 **WHEREAS, continued representation is necessary to protect the Nation's interests in these**
10 **matters; and**

11 **WHEREAS, the Initiative Legal Research budget in the amount of \$12,500 (Account No. 24-1809-**
12 **810) was approved by the Legislative Council in Resolution No. 01-454 (Schedule 2) for**
13 **the first quarter of fiscal year 2002 for legal costs associated with implementation of**
14 **the Initiative; and**

15 **WHEREAS, the Attorney General has proposed an attorney contract with the Attorneys, in the**
16 **amount of \$12,500.00, a copy of which is attached hereto; and**

17 **WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of**
18 **an Attorney Contract with the Attorneys on such terms.**

19 **NOW THEREFORE, BE IT RESOLVED THAT:**

- 20 **1. The Tohono O'odham Legislative Council hereby approves an Attorney Contract**
21 **with the Attorneys in the amount of \$12,500 for the period ending December 31,**
22 **2001 and in the form attached hereto.**
- 23 **2. Funding for the Attorney Contract shall be provided under the Initiative Legal**
24 **Research budget (Account No. 24-1809-810).**
- 25 **3. The Chairman of the Nation is authorized and directed to execute the Attorney**
26 **Contract.**
