

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Attorney Contract with the Law Firm of Quigley & Whitehill, P.L.C.)**

RESOLUTION NO. 01-534

1 **WHEREAS, by Resolution Nos. 99-593 and 2000-498, the Tohono O'odham Legislative Council**
2 **approved an Attorney Contract with the law firm of Quigley, Tang & Whitehill, P.L.C.,**
3 **now known as the law firm of Quigley & Whitehill, P.L.C. (the "Attorneys"), to provide**
4 **legal representation with respect to matters affecting the trust status of the San Lucy**
5 **Farm and litigation and negotiations related to the Central Arizona Project (CAP); and**

6 **WHEREAS, the Attorney Contract expired on September 30, 2001; and**

7 **WHEREAS, the CAP litigation is pending and certain issues regarding the trust status of the San**
8 **Lucy Farm are unresolved; and**

9 **WHEREAS, continued representation regarding ongoing matters is required to protect the**
10 **Nation's interests; and**

11 **WHEREAS, the Operating Budget for the Office of Attorney General for the first quarter of Fiscal**
12 **Year 2002, as approved by the Legislative Council in Resolution No. 01-454, has**
13 **sufficient funds for an attorney contract in the amount of \$5,000.00 for representation**
14 **in these proceedings; and**

15 **WHEREAS, the Attorney General has proposed an attorney contract with the Attorneys, in the**
16 **amount of \$5,000.00, a copy of which is attached hereto; and**

17 **WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of**
18 **an Attorney Contract with the Attorneys on such terms.**

19 **NOW THEREFORE, BE IT RESOLVED THAT:**

20 **1. The Tohono O'odham Legislative Council hereby approves an Attorney Contract**
21 **with the Attorneys in the amount of \$5,000 for the period ending December 31,**
22 **2001 and in the form attached hereto.**

23 **2. Funding for the Attorney Contract shall be provided under the authority of**
24 **Resolution No. 01-454 in the operating budget for the Office of Attorney General.**

25 **3. The Chairman of the Nation is authorized and directed to execute the Attorney**
26 **Contract.**
