
1 **WHEREAS, the Budget & Finance Committee, Executive Review Committee and Tri-Branch**
2 **Representatives reviewed the revenue projection and available revenues for FY 2002;**
3 **and**

4 **WHEREAS, the Budget & Finance Committee, Executive Review Committee and Tri-Branch**
5 **Representatives recommends adoption of FY 2002 revenues projected and available**
6 **in the amount of \$43,639,044.71 to fund the Nation's budget for 2002.**

7 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**
8 **it hereby approves the attached projected revenues in the amount of \$43,639,044.71**
9 **for the purpose of funding the FY 2002 budgets of the Tohono O'odham Nation.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
11 **of OCTOBER, 2001 at a meeting at which a quorum was present with a vote of 1,791.05 FOR; 124.05**
12 **AGAINST; 0- NOT VOTING; and 502.4 [05] ABSENT, pursuant to the powers vested in the Council by**
13 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
14 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
15 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
16 **18, 1934 (48 Stat. 984).**
