
1 WHEREAS, the following named person(s) have formally relinquished their membership in the

6 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does hereby
7 recognize that the above-named person(s) have relinquished their membership in
8 this Nation, and does hereby order that their name(s) be deleted from the
9 membership roll.


10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH Day
11 of NOVEMBER, 2001 at a meeting at which a quorum was present with a vote of 1,984.45 FOR; -0-
12 AGAINST; 115.35 NOT VOTING; and 317.7 [07] ABSENT, pursuant to the powers vested in the Council
13 by Article II, Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham
14 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting
15 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16
16 of the Act of June 18, 1934 (48 Stat. 984).
