8	WHEREAS, the Agricultural Committee has recently developed an updated plan of operation to							
9	reflect its powers, oversight authority, membership, meetings, and other matters; and							
10	WHEREAS, because the Agricultural Committee's updated Plan of Operation will replace the plan							
11	adopted pursuant to Resolution No. 79-88, it is necessary to rescind Resolution No. 79-							
12	88.							
13	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby							
14	rescinds Resolution No. 79-88, "Adoption of the Agricultural Committee's Plan of
