(In Support and Approval of the FY 2002 Schuk Toak District Set-A-Side Budget)**

**RESOLUTION NO. 01-559**

1 WHEREAS, the Schuk Toak District Council held their regular Budget Council meeting on October  
2 9, 2001; and

3 WHEREAS, the Schuk Toak District Council did review their Set-A-Side Budget for Fresno, San  
4 Pedro, Queens Well, in the total amount of \$166,666.65; and

5 WHEREAS, the Schuk Toak District FY 2002 Set-A-Side Budget will commence on October 1, 2001  
6 and end on September 30, 2002.

7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does approve  
8 and support the Schuk Toak District FY 2002 Budget in the total amount of  
9 \$166,666.65.

10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>. Day  
11 of NOVEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-  
12 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
13 Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by  
14 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
15 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
16 18, 1934 (48 Stat. 984).


