

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Agreement Between the Nation and Gu Achi District Regarding
KOHN-FM)

RESOLUTION NO. 01-565

1 **WHEREAS, by Resolution 01-509, the Council did authorize the Chairman to "execute any and all**
2 **leases and such agreements" necessary in furtherance of construction of a transmitter**
3 **tower and studio facilities for KOHN-FM, "subject to review by the Tohono O'odham**
4 **Realty Office and the Legislative Council Cultural Preservation and Natural Resources**
5 **Committees, and approval by the Legislative Council; and**


6 **WHEREAS, the Chairman of the Gu-Achi District has proposed terms and conditions for use of the**
7 **parcel identified as the Studio Site under Resolution 01-509 in a letter dated November**
8 **07, 2001 (the "Letter of Intent"), as attached and incorporated by this reference; and**

9 **WHEREAS, staff of KOHN-FM have presented the Letter of Intent to the Council's Committees of**
10 **Cultural Preservation and Natural Resources, as well as the Nation's Realty Office and**
11 **Office of Attorney General.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Chairman of the Nation is hereby authorized to**
13 **execute a Memorandum of Agreement with Gu Achi District under the terms expressed**
14 **in the District's Letter of Intent dated November 07, 2001.**


15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**

18 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
19 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
20 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
21 **Stat. 984).**


