

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval and Acceptance of the funding for the USDA National Animal Health  
Emergency Management System grant)**

**RESOLUTION NO. 01-571**

1 **WHEREAS, the Tohono O'odham Nation is devoted to the goals of protecting the environment and**  
2 **safe guarding the health and well being of the Nation's members; and**

3 **WHEREAS, Foot and Mouth Disease and other foreign animal diseases present a potential threat**  
4 **to the resources of the Nation; and**

5 **WHEREAS, the Natural Resources Department has prepared a grant application for submission**  
6 **to the United States Department of Agriculture (USDA) Animal and Plant Health**  
7 **Inspection Service (APHIS); and**

8 **WHEREAS, APHIS has indicated that is has reserved \$48,849.00 for the Nation to use to conduct**  
9 **emergency preparation and public awareness outreach activities to prepare the**  
10 **Nation in the event that Foot & Mouth Disease or other foreign animal diseases**  
11 **become imminent threats.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council**  
13 **hereby accepts the award for \$48,849.00 from the USDA National Animal Health**  
14 **Emergency Management System to implement the Foreign Animal Disease**  
15 **Preparedness Program.**

16 **BE IT FURTHER RESOLVED, by the Tohono O'odham Nation Legislative Council that the Tohono**  
17 **O'odham Nation's Official, to wit: the Chairman, Vice Chairman and any designated**  
18 **official are hereby authorized to negotiate and execute the grant, provided however,**  
19 **that any amendments affecting the funding for funding levels of the grant shall be**  
20 **submitted for further prior approval.**

21 **BE IT FINALLY RESOLVED, that the Natural Resources Department is authorized to expend funds**  
22 **from this grant beginning on October 01, 2001.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup> Day**  
25 **of NOVEMBER, 2001 at a meeting at which a quorum was present with a vote of 1,854.0 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and 563.5[10] ABSENT, pursuant to the powers vested in the Council by**  
27 **Section 1 (i)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
30 **18, 1934 (48 Stat. 984).**
