

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Five Percent FY 2002 Cost of Living Adjustment for Tohono O'odham
Judicial Court Judges)**

RESOLUTION NO. 01-574

1 **WHEREAS, pursuant to Section 9 of Article VIII of the Constitution of the Tohono O'odham Nation,**
2 **("Constitution"), "The judges of the Tohono O'odham Courts shall receive for their**
3 **services a compensation to be established by the Tohono O'odham Council, which**
4 **shall not be diminished during their continuance in office.;" and**

5 **WHEREAS, pursuant to Resolution No. 97-357, the Council adopted a salary schedule for the**
6 **Nation's judges; and**

7 **WHEREAS, due to subsequent Council-approved market and cost of living adjustments, judges'**
8 **current salaries exceed the \$55,135.00 salary cap set by Resolution No. 97-357; and**

9 **WHEREAS, the Legislative Council is declining to adopt the FY 2002 judicial salary increases**
10 **proposed by the Judicial Administration, but finds a cost of living increase is**
11 **warranted; and**

12 **WHEREAS, the Council finds that approving a five percent (5%) cost of living increase for the**
13 **Nation's six full-time judges would be more appropriate.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
15 **a five percent (5%) cost of living increase for the Nation's six full-time judges**
16 **retroactive to October 1, 2001 and effective upon adoption of Judicial Branch FY 2002**
17 **budget.**

18 **BE IT FINALLY RESOLVED that, by adopting this resolution, the Legislative Council hereby**
19 **suspends Resolution No. 97-357.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
21 **of NOVEMBER, 2001 at a meeting at which a quorum was present with a vote of 1,707.65 FOR;**
22 **565.35 AGAINST; -0- NOT VOTING; and 144.5 [07] ABSENT, pursuant to the powers vested in the**
23 **Council by Section 9 of Article VIII of the Constitution of the Tohono O'Odham Nation, adopted**
24 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**
