4	shall not be diminished during their continuance in office."; and					
5	WHEREAS, pursuant to Resolution No. 97-357, the Council adopted a salary schedule for the					
6	Nation's judges; and					
7	WHEREAS, due to subsequent Council-approved market and cost of living adjustments, judges'					
8	current salaries exceed the \$55,135.00 salary cap set by Resolution No. 97-357; and					
9	WHEREAS, the Legislative Council is declining to adopt the FY 2002 judicial salary increases					
10	proposed by the Judicial Administration, but finds a cost of living increase is					
11	warranted; and					
12	WHEREAS, the Council finds that approving a five percent (5%) cost of living increase for the					
13	Nation's six full-time judges would be more appropriate.					
14	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves					
15	a five percent (5%) cost of living increase for the Nation's six full-time judges					
16	retroactive to October 1, 2001 and effective upon adoption of Judicial Branch FY 2002					
17	budget.					
18	BE IT FINALLY RESOLVED that, by adopting this resolution, the Legislative Council hereby					
19	suspends Resolution No. 97-357.
