RESOLUTION NO. 01-578

1	WHEREAS, the Tohono O'odham Nation is in the process of purchasing approximately 1,181 acres
2	of land in Sections 25 and 26, Township 5 South, Range 5 West, in Maricopa County
3	adjacent to San Lucy Village (the "Property") pursuant to the authority in Resolution
4	No. 01-500, and has appropriated sufficient funds for the purchase price; and
5	WHEREAS, the Property is being acquired under the authority of the Gila Bend Indian
6	Reservation Lands Replacement Act, Public Law 99-503; and
7	WHEREAS, San Lucy District has identified additional costs which will likely be incurred in
8	preparing to purchase the Property such as survey costs (estimated at \$20,000),
9	monitor well drilling costs (estimated at \$25,000 per well), environmental assessment
10	(estimated at \$30,000), closing costs (estimated at \$5,000), and possible additional fees
11	for extensions on closing which the Nation may request from the Seller, and requests
12	that \$250,000 (Two Hundred Fifty Thousand Dollars) be appropriated from the San
13	Lucy Public Law 99-503 account to pay for pre-purchase contingency costs.
14	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council appropriates
15	\$250,000 (Two Hundred Fifty Thousand Dollars) from the San Lucy Public Law 99-503
16	account for any reasonably necessary pre-purchase contingency costs related to the
17	proposed purchase of approximately 1,181 acres from the Gila Bend Investment Group
18	Limited Partnership, such funds to be expended under the authority of the San Lucy
19	District Chairperson.
