

1 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above named applicant  
2 is eligible for enrollment as a member of the Tohono O'odham Nation under  
3 Section 1(a) or (b) of Article II of the Constitution of the Tohono O'odham Nation,  
4 and that their application is approved, as herein above indicated.

5 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of the Tohono  
6 O'odham Nation reduce this final determination in writing regarding each of the  
7 foregoing applications for enrollment in accordance with Section 1(a) of Article  
8 XIII of the Enrollment Ordinance; give notice of this Council's determination in  
9 accordance with Section 2 of Article XIII of the Enrollment Ordinance; and place  
10 the names of each applicant upon the membership roll of the Tohono O'odham  
11 Nation in accordance with Sections 2 and 3 of Article X of the Enrollment  
12 Ordinance.

13 The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 03<sup>RD</sup>. Day  
14 of DECEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,256.8 FOR; -0-  
15 AGAINST; -0- NOT VOTING; and 160.7 [08] ABSENT, pursuant to the powers vested in the Council  
16 by Section I of Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'Odham  
17 Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting  
18 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16  
19 of the Act of June 18, 1934 (48 Stat. 984).
