

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving an Attorney Contract with Robert R. Yoder)**

RESOLUTION NO. 01-595

1 WHEREAS, pursuant to Resolution Nos. 2000-047 and 2000-493, the Tohono O'odham Legislative  
2 Council approved an Attorney Contract with Robert R. Yoder to provide legal  
3 representation with respect to retirement plans and the Nation's 401 (k) Plan; and

4 WHEREAS, the Attorney Contract expired on September 30, 2001; and

5 WHEREAS, the Attorney General and the Human Resources Office recommend extension of the  
6 Attorney Contract for the first quarter of Fiscal Year 2002, to enable Mr. Yoder to  
7 continue his advice and representation of the Nation in these matters.

8 NOW, THEREFORE, BE IT RESOLVED THAT:

- 9 1. The Tohono O'odham Legislative Council approves an Attorney Contract with  
10 Robert R. Yoder in the amount of \$4,000 for the period ending December 31, 2001  
11 and in the form attached hereto.
- 12 2. Funding for the Attorney Contract shall be provided under the authority of  
13 Resolution No. 01-454 from Account No. 1-1006-615.
- 14 3. The Chairman of the Nation is authorized to execute the Attorney Contract.

15 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>th</sup> Day  
16 of DECEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,323.35 FOR; 94.15  
17 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
18 Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
19 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
20 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
21 Stat. 984).
