9		favorable determination that the Plan was a qualified plan under the IRC, subject to							
10		the adoption of certain amendments proposed during the IRS review of the Plan; and							
11	WHEREAS,	attached hereto are the proposed amendments to the Plan (the "First Amendment")							
12		which incorporate the revisions requested by the IRS, as well as certain clarifying							
13		changes to the Plan and model amendments authorized under federal law; and							
14	WHEREAS,	, the Budget & Finance Committee recommends adoption of the First Amendment by							
15		the Legislative Council
