2	Council to use its 2001 Supplemental Gaming Revenue for new home construction and					
3	home renovations pursuant to Resolution No. 01-484; and					
4	WHEREAS, the San Xavier District is now requesting to amend its resolution (Resolution No. SXDC					
5	10-01-11) by modifying the 2001 Supplemental Gaming Revenue Budget to provide only					
6	new home construction; and					
7	WHEREAS, the San Xavier District would like to utilize the entire \$500,000 supplemental gaming					
8	revenue funds for construction of four or five new homes.					
9	NOW, THEREFORE, BE IT RESOLVED, that the Tohono O'odham Legislative Council hereby					
10	rescinds Resolution No. 01-484 (San Xavier District Use of 2001 Supplemental Gaming					
11	Revenues of \$500,000 for New Home Construction and Renovation to Existing Homes).					
12	BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby supports and					
13	grants San Xavier District's request to modify its 2001 Supplemental Gaming					
14	Distribution budget in the amount of five-hundred thousand dollars (\$500,000) for					
15	new home construction only.
