

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving The Hickiwan District FY 2002 Budget)

RESOLUTION NO. 01-611

1 **WHEREAS, the Hickiwan District Council met on December 04, 2001 at which a quorum was**
2 **present to discuss the FY 2002 Budget; and**

3 **WHEREAS, the Hickiwan District Council has been on continuing resolution of the FY2001 Budget;**
4 **and**

5 **WHEREAS, the District allocation from the Gaming Revenue distribution was in the amount of**
6 **\$ 651,013.11 and \$ 32,977.94 of the 30% from the Golden Ha:san Casino which totals**
7 **\$ 683,991.05; and**

8 **WHEREAS, the Hickiwan District will place the funds in the First Union Securities account to cover**
9 **the Districts FY 2002 Budget.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
11 **approve the FY 2002 Budget of the Hickiwan District in the amount of \$683,991.05 and**
12 **that it be retro to October 01, 2001.**

13 **BE IT FURTHER RESOLVED that the Hickiwan District will place the funds in the amount of**
14 **\$683,991.05 in the First Union Securities account to cover the Hickiwan District FY**
15 **2002 Budget.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
17 **of DECEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,256.8 FOR; -0-**
18 **AGAINST; -0- NOT VOTING; and 160.7[04] ABSENT, pursuant to the powers vested in the Council by**
19 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
20 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
22 **18, 1934 (48 Stat. 984).**
