9	WHEREAS, the Legislative Judiciary Committee recommends that the Nation's Chief Judge						
10	Malcolm Escalante, be appointed as the Nation's state sovereignty protection						
11	representative in Councilman Encinas' place.						
12	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution						
13	No. 01-558 is hereby amended to replace Councilman Ambrose Encinas as the Nation's						
14	state sovereignty protection representative and to appoint Tohono O'odham Judicia						
15	Court Chief Judge Malcolm Escalante in his place.
