

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of FY 2003 Elderly Title VI Program Grant Proposal)**

RESOLUTION NO. 01-616

1 **WHEREAS, the Tohono O'Odham Nation has successfully operated a program for the elderly**  
2 **members of the Nation; and**

3 **WHEREAS, funding for the operation of the Elderly Program has been made possible in party by**  
4 **Title VI of the Older American's Act of 1978, as amended; and**

5 **WHEREAS, the Elderly Program is requesting approval of the three year project proposal and the**  
6 **first year budget in the amount of \$128,550.00; and**


7 **WHEREAS, the Elderly Program will benefit elder members of the Tohono O'odham Nation by**  
8 **providing for their nutritional and social support services.**

9 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**  
10 **hereby approves:**

- 11 1. **The Project proposal from April 01, 2003 to March 31, 2006.**
- 12 2. **That first year budget of \$128,550.00 which shall commence on April 01, 2002 and**  
13 **end March 31, 2003.**
- 14 3. **The Tohono O'odham Nation officials, to wit: The Chairman and Vice-Chairman**  
15 **or designated official are hereby authorized to negotiate and execute the grant,**  
16 **and expend such funds per attached budget. Provided however, that any**  
17 **amendments affecting the funding or funding levels of this contract shall be**  
18 **submitted for further prior approval by this Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>th</sup> Day**  
21 **of DECEMBER, 2001 at a meeting at which a quorum was present with a vote of 1,656.0 FOR; -0-**  
22 **AGAINST; 761.5 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
23 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
26 **Stat. 984).**
