1 **WHEREAS, the Sif Oidak District did review and discuss the Business Lease for Jonas Albert from**
2 **the White Horse Pass Community at a regular council meeting held on November 10,**
3 **2001; and**


4 **WHEREAS, the Sif Oidak District did approve a land assignment for Mr. Jonas Albert in the White**
5 **Horse Pass Community for 130 x 110 square feet to develop the livestock feed supply**
6 **business; and**

7 **WHEREAS, the Natural Resources Committee did meet and approve the business land lease**
8 **proposal on December 06, 2001.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby supports**
10 **and approves the Business Land Lease for Mr. Jonas Albert in Whitehorse Pass**
11 **Community within the Sif Oidak District.**

12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
13 **of DECEMBER, 2001 at a meeting at which a quorum was present with a vote of 1,511.5 FOR; 745.3**
14 **AGAINST; 160.7 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
15 **Section 1 (i) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
16 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
17 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
18 **Stat. 984).**


