| 8 | WHEREAS, on November 28, 2001 the National Congress of American Indians unanimously |
| 9 | adopted Resolution #SPO-01-006, which also opposed the creation of the Bureau of |
| 10 | Indian Trust Asset Management ("BITAM"); and |
| 11 | WHEREAS, an NCAI-sponsored Tribal Leaders' Caucus is scheduled for December 12, 2001 to |
| 12 | discuss the Department of the Interior reorganization effort; a consultation with the |
| 13 | Department of the Interior is scheduled for December 13, 2001; and |
| 14 | WHEREAS, it is in the Nation's best interest to delegate the authority to certain elected officials |
| 15 | to represent the Nation's position and act on the Nation's behalf at the caucus and |
| 16 | consultation. |
| 17 | NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby |
