

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Authorizing Fiscal Year 2002 Initiative Administration Budgets;
Appropriation of Additional Funds to the Reserve)**

RESOLUTION NO. 01-627

1 WHEREAS, Initiative IN-01-97 requires that the Nation provide for the annual administrative cost
2 of implementing the provisions of the initiative; and

3 WHEREAS, a reserve was established to fund the necessary administrative requirements; and

4 WHEREAS, the estimated unobligated balance of the established reserve is projected to be
5 \$1,118,040.00 at fiscal year end 2002; and

6 WHEREAS, the Executive Branch has prepared a Fiscal Year 2002 budget to continue its Initiative
7 Administration, as attached in the form Schedule 2 and incorporated by this
8 reference; and

9 WHEREAS, the total Fiscal Year 2002 budget, in the amount of \$1,598,360.18, will require an
10 additional appropriation of \$480,320.18 to the fund; and

11 WHEREAS, the budgets have been presented to the respective Legislative Oversight Committees
12 for review.

13 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:

- 14 1. The Executive Branch Fiscal Year 2002 Initiative Administration Budget, as
15 summarized in Schedule 2 hereto, in the full amount of \$1,598,360.18 is hereby
16 approved and authorized to be expended accordingly.
- 17 2. An additional \$480,360.18 is hereby appropriated to the Initiative Administration
18 reserve from the Nation's Gaming Revenues held in the Nation's Desert Diamond
19 Savings Account.

20 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH Day
21 of DECEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-
22 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
23 Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
24 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
25 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
26 18, 1934 (48 Stat. 984).




