**RESOLUTION NO. 01-629**

1 **WHEREAS, the Executive Branch has prepared and presented its Fiscal Year 2002 Budget to the**  
2 **Tohono O'odham Legislative Council; and**

3 **WHEREAS, the Executive Branch FY 2002 Budget funds regular department and program**  
4 **operations; and**

5 **WHEREAS, the Executive Branch FY 2002 Budget has been prepared to reflect employee longevity**  
6 **steps and market adjustments retroactive to October 1, 2001 as authorized by the**  
7 **Legislative Council.**

8 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the attached**  
9 **Executive Branch Fiscal Year 2002 Budget in the amount of \$40,392,192.05 is hereby**  
10 **approved.**

11 **BE IT FURTHER RESOLVED that the Legislative Council hereby appropriates \$40,092,192.05 for**  
12 **operations and an additional \$300,000.00 for contingency reserve to fund the**  
13 **Executive Branch Fiscal Year 2002 Budget.**

14 **BE IT FINALLY RESOLVED that the Executive Branch FY 2002 Budget and all employee**  
15 **compensation levels contained therein shall be retroactive to October 1, 2001.**


16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup> Day**  
17 **of DECEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-**  
18 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
19 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
20 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
22 **18, 1934 (48 Stat. 984).**


