(FY 2002 Indian Health Service)

RESOLUTION NO. 01-635

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **Indian Health Service; and**

3 **WHEREAS, the Legislative Council has approved Resolution No. 01-352 granting the Executive**
4 **authorization to submit the Annual Funding Agreement (AFA) to the Indian Self**
5 **Determination Act Master contract; and**


6 **WHEREAS, the Executive Branch developed approval of the following budgets as attached and**
7 **incorporated by this reference, to be effective October 1, 2001 through September 30,**
8 **2002 and request authorization to expend the funds:**

33 **funds for the programs listed herein above and as attached in the amounts indicated,**
34 **effective October 1, 2001 through September 30, 2002.**

1 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20th. Day
2 of DECEMBER, 2001 at a meeting at which a quorum was present with a vote of 2,417.5 FOR; -0-
3 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section
4 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
5 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
6 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
7 Stat. 984).




